- **2. Treasurer's report** John Parrella provided December treasurer's report; account balance is healthy and income from membership fees is as well. Expenses include buying gift cards for the January "21 Days of Giveaways" promotion, coop ad in Local Town News for December, and MBC scholarship payouts after students verify fall semester attendance.
- **3. Membership update** We have few new and renewing members in December and updated membership letters to include new townwide directory listing. Tonia offered to do another mailing (postcard or letter). Wayne recommends emphasizing the benefit of being in the directory. Local Town Pages gave us a quote of \$.85/piece for a letter mailing (all costs included). Board voted to approve an expenditure of approx. \$600 to do a membership acquisition mailing. Julie recommends including in the letter a way to opt out of the directory if the business is closed.
- **4. Economic Development Liaison update on Medway Restaurant Week: Art Prutsalis** Barbara at EDC plans to discuss Restaurant Week next week. EDC member Zack Knowlton will assist Art in surveying the restaurants to see how they would like to get involved in this special promotion.

#### **6. Directory update**: Wayne & John Haddad

Website traffic up 21% from 2019-2020. Lots of positive indicators in the tracking analysis. There's been a little lift to traffic into the new year. The directory is getting the bulk of the hits, followed by #shopmedway. Julie has asked the Town of Medway to add a tab on their website and promote the directory on Facebook.
